Bangladesh Islamic Law Research and Legal Aid Centre

Before the British rule, Islamic traditions and legal ideas were prevalent in every aspect of this country and society. Ever since the British power colonized this region, the practice of Islamic law was banished at the state level. Consequently, many detrimental changes have been in place in the Muslim mindset and lifestyle. Nowadays, questions are being raised about the effectiveness of Islamic law without having any proper idea about Islam. As such the propaganda against it is on the rise. Ignorance, confusion and misconceptions about Islamic law and its dynamics are increasing even among the Muslims.

Keeping in view the challenges of modern society and the state there is a need to present the overall welfare, usefulness and practical capabilities of Islamic law through the concerted efforts of both conventional and Islamic jurists. It is now strongly felt necessary to establish the truth that Islamic law contains sustainable elements for the establishment and development of the rights of all citizens regardless of religion and caste. This is not a myth; instead, history testifies that Islam has a glorious past of universal welfare. With the aim of building a prosperous future in the light of the golden past, the ‘Bangladesh Islamic Law Research and Legal Aid Center’ was established in 1995 and it started its institutional journey in 2005. The center is a non-profitable research and legal aid organisation approved and registered by the Government of Bangladesh.

Aims and objectives

This organisation endeavours to achieve the following aims and objectives:

1. Study and research on Fiqh based on the needs of the age and conduct collective ijihad (reasoning by an expert in Islamic law in finding a solution to a legal question) in solving contemporary and new issues;
2. To support (the stakeholders) in reforming the conventional law and justice system to ensure justice in the society;
3. To unveil the goodness of Islamic finance system in contrast to the interest based finance system;
4. To provide legal aid to the helpless people and the oppressed women and children
5. To guide the social service sectors to build a strong and poverty-free society through Zakat.



Activities

To achieve the aims and objectives the Bangladesh Islamic Law Research and Legal Aid Centre has undertaken the following projects:

- 1. Conducting law related research**
Identifying modern-days problems by the experts in the country's existing legal system and Islamic jurists and identifying solutions to them in the light of Islam.
- 2. Arranging academic seminars, conference and workshops**
Arranging national and international seminars, symposiums and workshops for skill development by the Islamic jurists, scholars and researchers from home and abroad.
- 3. Publishing journals**
Publishing a quarterly Bengali journal, a bi-monthly English journal, and an annual Arabic journal to analyze contemporary legal issues from an Islamic perspective.
- 4. Writing and translation of books**
Preparing research books, booklets, theses, research papers, etc. on Islamic law and to translate and publish informative books on Islamic law and Shariah from Arabic, Persian, Urdu, and English into Bangla.
- 5. Generating researchers**
To endeavour for making a group of researchers and presenters to research various aspects of Islamic law and prove its excellence, goodness, and usefulness.
- 6. Providing legal aid and encourage Alternative Dispute Resolution**
Providing legal aid to the helpless, poor and oppressed people in general and especially to people in cases of violence against women and children and false and harassing cases; taking initiatives to free the deprived, distressed and helpless prisoners deprived of human rights by providing free legal aid; applying Alternative Dispute Resolution (ADR) processes in the light of Islamic law for easy resolution of family and social disputes.
- 7. Creating social awareness**
Awakening people and encouraging them to eliminate social ills such as drug addiction, bribery, corruption, terrorism, dowry, etc.
- 8. Establishing a rich library**
Establishing a rich library by collecting books, research, and documentaries on various subjects including Islamic law, judiciary, justice, and human rights
- 9. Infrastructural development projects**
Establishing a law complex, a law institute, and an e-platform on law in order to complete the above project





A. Essay Competition

To encourage young and aspiring researchers, the Center organized a research essay competition in 2010 and 2011. In 2010, the topic of the essay was "Characteristics of the Society and State and Legal System of Medina Founded by the Prophet Muhammad (PBUH)" and in 2011, the topic of the essay was "Role of Islamic Law and Judiciary in the Formation of a Modern Welfare State". In this competition, which was held with the wide participation of students from madrasas, universities and colleges, the essays were verified and evaluated by an expert committee and the 1st, 2nd, 3rd and ten consolation prizes were awarded at separate events every year. The values of the 1st, 2nd and 3rd prizes was Tk. 24,000, 18,000 and 12,000 respectively and the next 10 people were given consolation prizes of Taka 1000. Such competitions are being organized continuously.

 - ❖ The organization has conducted an appeal case in the Supreme Court of Bangladesh against the judgment of a division bench of the High Court regarding the provision of maintenance to divorced women until death that is against the Quran and Sunnah and has obtained an order to quash the judgment of the High Court division of the Supreme Court.
 - ❖ The organization has filed an appeal in the Supreme Court against the judgment of the same bench that it is not permissible for a husband to take a second wife during lifetime of the first wife under any circumstances in Islam and has recommended to the government to formulate a single civil code for all in this respect, regardless of Muslims, Hindus, Buddhists, and Christians, and has obtained a judgment to quash the above recommendation.
 - ❖ The organization has taken appropriate part in the appeal case of the Supreme Court and has obtained a positive judgment on the validity of fatwas against the judgment of the same bench declaring 'Issuing all types of fatwas in Islam as prohibited'.

Family Aid Project

A new project called Family Aid has been taken up in 2023 under the organization's Legal Aid Project. In 2023, 3 webinars were held to create social awareness about the rights and duties of all family members, including awareness about women's and children's rights, and counseling assistance was provided to 200 troubled families, Sharia counseling was provided to 100 families, and 30 social problems were resolved. Efforts are underway to further expand the work of the Family Aid Project.

6. Library Project

Around 2500 books on different subjects of Al-Quran, Al-Hadith, Al-Fiqh, Fatawa Wa Masail, Usul Al-Fiqh/Jurisprudence, Al-Aqidah, Islamic Law, Encyclopedia, Conventional Law, History, Political Science, International Affairs, Women and Feminism, Economics/Finance are available in the library of the organization. New books and journals are being added to it constantly and its development is on progress.




